Faculty Orientation

Faculty orientation for academic year 2011/2012 was held on September 17, 2011, at the academic complex. Dr. Coker George, Dean of the College of Agriculture and Food Sciences, facilitated an interactive session during which faculty were asked to identify what their expectations were as they prepare students for worthy service, and interact with other divisions of the University. Mr. William Harris, Chair of Department of Secondary Education, made a brief presentation on the socio-economic, geographic, and historic background of Maryland County and the rest of the southeast region. Also presented by Mr. Harris (Emcee for the event), were TU's, organizational structure, Vision, Mission, Core Values, and Principles of Operation. Thematic presentations, reflective of TU's Core Values and Principles of Operation were facilitated by the following; Dr. Lucky Ehigiator, Dean of the College of Health Science, on the roles and responsibilities of faculty; Ms. Iona Thomas -Connor, Chair of the Department of Nursing, on teaching effectiveness: Rev. Amb. Gerald B. Coleman, Dean of the College of Engineering and Technology, on technical competence (with regards to the use of modern information technol-

ogy) by faculty; Mr. Stephen Jallah, a faculty in the College of Management and Public Administration, on team communication; Ms. Marie Simmons, faculty in the College of Arts and Sciences, on advisement and consultation hours with student; Mr. Isaac George, Acting Dean of the College of Management and Public Administration, on community involvement; and Dr. Jerome Griffin, Dean of the College of Education, on the meaning and importance of research to faculty. Newly hired faculty who attended the orientation include, Mark Wilson (engineering); Dr. Anthony Nevin (history); Annalyn Macalalad (English); Myth Carbajosa (biology and chemistry); Stephen Jallah, previously an adjunct at TU, (management); Mulbah Tokpah (nursing); William Harris, previously the Human Resources Director at TU, (education).

Mr. Lino Sciarra of UNMIL, who served as an adjunct at TU, said that he was leaving UNMIL for a new assignment at UN Headquarters in New York. Dr. Enanoria-Carbajosa, on behalf of the TU family, thanked Mr. Sciarra for all his support to TU, and wished him success in his new assignment.

Tubman University has been selected to be one of Liberia's three National Competence Centers, under the framework for Supporting Energy Efficiency for Access in West Africa (SEEA-WA). TU was recommended at the August 27, 2011, Forum of National Focal Points for Renewable Energy and Energy Efficiency (ECREEE), held in Kumasi, Ghana, after it was decided at the conference that there be three National Competence Centers in each ECOWAS member state. The University of Liberia and the Stella Maris Polytechnic are the other two National Competence centers identified for Liberia. The selection of TU as one of

Liberia's National Competence Centers under the frame work of supporting energy efficiency complements the University's effort to transition to, and promote education in, clean, efficient and renewable energy. Towards that goal the University is pursuing a number of initiatives; one of our budget priorities for the 2011/2012 fiscal year is to procure and install a number of solar lamps on campus; the University has an environmental committee with the primary goals of securing, maintaining, and enhancing a green and safe environment at TU; and participating in positive actions that promote clean,

efficient and renewable energy. With regards to the third initiative, TU has held, participated and supported events/projects on renewable energy and green environment; the latest of such is the University's participation in the Africa Energy Watchsponsored Environmental Conference in Washington, DC, USA, on September 21-22, 2011. Vice President Rita Townsend represented Tubman University at that conference. Two items that were significant to TU's participation and contribution at the

Conference were the development of an environmental science curriculum, and the establishment of an environmental research center. With respect to the former, VP Townsend (proxy for Dr. Elizabeth Davis-Russell at the Conference) signed a joint articulation between the University of the District of Colombia and William V.S. Tubman University with a "desire to promote sustainable cooperation in the field of environmental education, academic research, science and technological innovation, and renewable and alternative sources of energy".

Association of Liberian Engineers in the United States (ALEUSA) to partner with TU

Mr. Richard Bantu, an executive of the Association of Liberian Engineers in the USA, paid a three-day visit to Tubman University, from Thursday ,September 29 to Saturday, October 1, 2011. The itinerary for Mr. Bantu's visit to TU included the following; reception and welcome by faculty and staff of the College of Engineering and Technology; a tour of TU facilities; a tour of Harper City; and a dinner reception with members of the President's Council, TU faculty and staff, and student representatives of the College of Technology. At the dinner reception, Rev. Gerald Coleman introduced Mr. Bantu as a representative of ALEUSA that was visiting TU to identify, assess, and review potential areas of cooperation between TU and ALEUSA. Rev. Coleman highlighted in a PowerPoint presentation, the expectations of Tubman University in a partnership with ALEUSA. They include the following; support in faculty recruitment, support in curriculum development, providing service as volunteer faculty on a semester basis, providing mentoring/

job opportunities for our students, assist in establishing a national standard for professional engineering practice in Liberia, and assist with engineering textbooks and lab equipment. These expectations were earlier conveyed to the executives of ALEUSA in a letter from Rev. Gerald Coleman, in pursuit of an effort to cultivate a potential relationship/partnership between TU and ALEUSA. Mr. Bantu, on behalf of ALEUSA, welcomed TU's expression of interest to partner with ALEUSA, and indicated that ALEUSA would be delighted to assist TU in the areas identified by Rev. Coleman. He said that he will return to the US with report of the potential for a great partnership between TU and ALEUSA. Mr. Bantu, on behalf of ALEUSA, donated a projector screen board to TU. He said that he will visit TU again in November, 2011, by which time he expects that an MOU between TU and ALEUSA would have been signed.
